

# Jerusalem Township Board of Trustees Meeting Held on May 22, 2018

The Board of Trustees of Jerusalem Township met in regular session meeting on the above date at 7:00 p.m. in the Office of the Trustees, 9501 Jerusalem Road, Curtice, Ohio 43412

Dave Bench opened the meeting with a moment of silence followed by the pledge of allegiance with the members as listed during roll call:

# **Approval of Previous Minutes:**

After review by the board, Dave Bench made a motion to accept the May 8, 2018 meeting minutes as presented to the board. Seconded by Beau Miller with roll call as follows:

Fiscal Officer: Joel Moszkowicz

Joel reported a fund status of \$573,074.08 in pooled investments and \$220,058.42 in our checking account. Also reporting of warrants 16608-16645 and electronic payments 68-2018 through 70-2018 to pay in total \$43,649.93. Additionally, we deposited \$1,392.06. Dave Bench made a motion to accept the payment and fund status report, seconded by Beau Miller with roll call as follows:

Joel reported that a motion needs to be made to accept the 2018-2019 Otarma Insurance proposal

but wants the board to review the idea of increasing our general liability insurance. After further review, Dave Bench made a motion, seconded by Beau Miller to increase the general liability insurance 1 million additional for a total insurance premium of \$30,043.00. Roll call as follows:

Linda will work the Oregon persecutor through Oregon municipal court, the next step is to send the letter that the property owner received over to the court.

Maggie Hart reported that 11987 has trash everywhere with a generator providing power to the home, also there a number of cats hanging around the property.

Le Anna Martin asked Linda for a list of noxious weeds, one will be provided through the State resources.

Linda Martin reported that property 12450 La Fontaine, property to the west is over grown, laying water and weeds.

Tonya Myrice 525 Coffee is having draining issues into the catch basin, Kevin will inspect.

Kevin reported that flooding on Seaman, Sacs, Cedar Point and Cousino and the that the hump by CCYC on bono road is closed from erosion. He reported that we gave the City of Oregon more sandbags and that a joint effort with both Fire Departments need to occur to refill sandbags. They received 500 loaded and 1000 empty bags, we are getting 3000 more. Lake Erie tree removed danger tree at Canal and Corduroy road. Low trees on Howard road between Lakeway and Corduroy are reported, Kevin will notify the County. Also reported, the private beach sign has been installed.
