

# Jerusalem Township Board of Trustees Meeting Held on February 25, 2020

The Board of Trustees of Jerusalem Township met in regular session meeting on the above date at 7:00 p.m. in the Office of the Trustees, 9501 Jerusalem Road, Curtice, Ohio 43412.

Mark Sattler opened the meeting with a moment of silence followed by the pledge of allegiance with the members as listed during roll call:

#### **Approval of Previous Minutes:**

After review by the board, Beau Miller made a motion to accept the February 11, 2019 regular meeting minutes as presented to the board. Seconded by Mark Sattler with roll call as follows:

#### Fiscal Officer:

In Joel's absence, Mark reported a fund status of \$594,608.70 in pooled investments and \$96,803.13 in our checking account. Also reporting of warrants 18408 – 18441 totaling \$21,290.12. We had deposits totaling \$5,673.12 since last meeting. Beau Miller made a motion to accept the payment and fund status report, seconded by Mark Sattler with roll call as follows:

## Fire Department: Chief Parasiliti is out of town

In Chief Parasilti's absence, Beau reported that asbestos was found in the outer walls of the training house. Three bids for asbestos abatement have been received. Chief Parasiliti recommended the low bid from Erie Environmental in the amount of \$1,900 to abate the asbestos so that the demolition of the training house can resume. ### **New Business:**

- 1. LCTA Meeting Mark Sattler and Beau Miller reported on the February 20<sup>th</sup> meeting on the 911 consolidation plan. Springfield Township has prepared an alternative proposal. That discussion was covered by Channel 11 news and will be circulated to all 21 Jurisdictions for comments and revisions. If there is sufficient support, this alternative proposal will be submitted to the Lucas County Commissioners for consideration. Significant issues concern the ability of all jurisdictions to pay for their assessment, the potential for a County-wide levy to pay for the allocated cost, and the governance structure of the proposed consolidated 911 service.
- 2. US Census Bureau Mark Sattler and Beau Miller reviewed the US Census Bureau's boundary verification. They determined that the boundary verification was correct.
