

Jerusalem Township Board of Trustees Meeting Held on May 11, 2021

The Board of Trustees of Jerusalem Township met in virtual session meeting on the above date at 7:00 p.m. through Zoom Meeting Online.

Dave Bench opened the meeting at 7:00 p.m. with a moment of silence followed by the pledge of allegiance with the members as listed during roll call:

Approval of Previous Minutes:

After review by the board, Mark Sattler made a motion to accept the April 27, 2021 Regular meeting minutes. Seconded by Beau Miller with roll call as follows:

Fiscal Officer: Joel Moszkowicz

The Fiscal Officer reported a fund status of \$598,114.82 in pooled investments and \$321,722.96 in our checking account. We made payments with warrants 19706-19745 and electronic payments 62-2021 through 65-2021 totaling \$63,931.47. Deposits since last meeting made totaling \$728.00. Mark Sattler made a motion to accept the payment and fund status report, seconded by Beau Miller with roll call as follows:

- 1. Trash Beau Miller is going to work with Lucas County so we can get some bids for future consideration.
- 2. Tree Planting no update.
- 3. Sheriff Road Patrol no update from the City of Oregon Police Division.
- 4. Howard Farms Metroparks no update from the planning commission.

Tony reported that on the Fire department side of things with the development of phase 2, he wants to make sure the board understands we need a face-to-face partnership with the Metroparks just as we experienced with phase 1.

- 5. Storm Water Discharge Report Mark Sattler reported that the Township has to login and apply for storm water money where in the past it was done for us through Lucas County. This is done every 4 to 5 years with the deadline by June 30th.
- 6. Shoreline Erosion Control Developments no update. The board will need to review the material before any public discussion.
- 7. American Rescue Plan no update.
- 8. Website Updates Mark Sattler reported some changes being made on the website to promote local businesses and tourism. These changes were discussed last meeting and through the Comprehensive plan efforts.
- 9. 911 Consolidation Update no update.
- 10. Townhall Meeting Beau Miller asked the other board members if anyone has an interest in setting up a town hall or office hour opportunity for members of the community each month. It was brought up that from the special meeting for Dollar General that some residents feel that a weekend time frame for a discussion would be beneficial. The board will consider the idea and some polling will be conducted on social media.

Mr. Mike Mackey - was asked his thoughts, he felt either way, it would be best to ask members of the community to see what they feel is of value.

New Business:

1. Unlimited Trash Pickup - Mark reported that Republic collected 100 tons, normal curbside estimate might be no more than 50 tons in 2021. If we do something with 1-2 staged locations instead of curbside, we might only see a 50% participation rate which might only yield 25 tons of refuse. Republic proposed staging three trucks (garbage trucks with a laborer) to facilitate loading) with a 3-4 hour window. The cost of this is estimated to be about \$7,000.00. This is a
