

Jerusalem Township Board of Trustees Meeting Held on February 22, 2022

The Board of Trustees of Jerusalem Township met in-person in the Township Meeting Room at 9501 Jerusalem Road and by virtual session through Zoom Meeting Online on the above date at 7:00 p.m.

Beau Miller opened the meeting at 7:00 p.m. with a moment of silence followed by the pledge of allegiance with the members as listed during roll call:

Approval of Previous Minutes:

Mike Skitowski and the Recreation Board will interview the candidates at their March 1 Rec Board meeting and provide recommendations to the Board of Trustees. On March 8th the Trustees will interview the candidates during the scheduled meeting in Executive Session. Those interviews will start around 7:45 p.m. after a short regular board of trustees meeting.

- 6. Route 2 Bridge Starting on March 7th closed for 75 days. The Fire Department is making plans for routing of responding vehicles. Mike Stormer will place better signs for road closure at I-280.
- 7. Organizational Structure no update. Last meeting took care of everything to date.
