

Jerusalem Township Board of Trustees Meeting Held on August 9, 2022

The Board of Trustees of Jerusalem Township met in-person in the Township Meeting Room at 9501 Jerusalem Road and by virtual session through Zoom Meeting Online on the above date at 7:00 p.m.

Beau Miller opened the meeting at 7:00 p.m. with a moment of silence followed by the pledge of allegiance with the members as listed during roll call:

Beau Miller, present Dave Bench, present Mark Sattler, present

Approval of Previous Minutes:

After review by the board, Mark Sattler made a motion to accept the July 26, 2022 Regular meeting minutes. Dave Bench seconded with roll call as follows:

The Fiscal Officer is on a fire call and will come in later to the meeting to complete his report.

Fiscal Officer: Joel Moszkowicz

The Fiscal Officer's report indicated a fund status of \$600,723.33 in pooled investments and \$750,778.30 in our checking account. We made payments with warrants 20883 – 20959 and electronic payments 104-2022 through 107-2022 totaling \$33,286.08. Deposits made since last meeting \$19,840.71.

Mark Sattler made a motion to accept the fiscal officer report seconded by Beau Miller with roll call as follows:

Regarding township owned properties, the Township was notified by the State of Ohio that the properties the Fiscal Officer applied for an exemption from regular property taxes (while held by the Township Government) are approved but below are three properties with high special assessments (which are not exempted while held by the Township Government):

810 Water - \$3776.04 in assessments 432 West - \$799.08 in assessments 796 Howard - \$905.34 in assessments

The Fiscal Officer expressed his concern about acquiring properties without knowledge of what the assessments are and then how long it takes to rid ourselves of these liabilities by transferring the properties to the new owner. He would like the board to hold off sending the land bank our signed documents until we understand what the assessments are for the properties approved from the zoning report from tonight's meeting. Beau Miller agrees and asks the zoning inspector to determine what the assessments are. The Fiscal Officer asked that we get that number and if it is reasonable, no need to wait till next meeting to have Linda send the paperwork into the landbank. Mark Sattler stated the Township is in the process of developing an active marketing effort to list properties for sale and return them to private owners for use. Elvis Shepherd indicated he is working with a good contact for the this.

Mark Sattler also asked Linda to check on assessments. Mark Sattler asked in the future any properties are brought forward, the assessments are included in the information shared with the board.

Mark Sattler was contacted by residents in the Curtice area regarding the noise, threats, intimidation, and slashed tires believed to be resulting from Luce Trucking. He advised the concerned residents to contact the police when these incidents occur. There is also noise after 2:30 a.m. and Mark Sattler is very concerned over the fact people are scared for their own personal safety. Linda commented this is an active zoning issue and the court favored the Township with the restriction that the business could only operate from 6:00 a.m. to 10:00 p.m. She reported that people need to step forward and testify in court but people are afraid to participate in any legal proceedings. Linda reported a \$100.00 a day fine could be requested by securing approval of the board of trustees and then asking the court judge to impose the daily fine as a means of enforcement.

Maintenance: Kevin Chapman

Road project is starting in the next few days but before the Metroparks get their property tar and chipped through the same contractor. As soon as he receives a notice of the project starting, the Township will send out a notice regarding the roads in Howard Farms, Rialto Road and Main Street in Bono with the project being completed over two days.

Kevin spoke with Lake Erie Tree and three problem areas are still outstanding. He will be reaching out to ensure they follow-up on these areas. He is also working on two door closers for the fiscal officer office, but the locks have been changed.

Cemetery: Kevin Chapman

Two full burials this past week. We have 22 graves left to sell in the old section with separate graves only. Kevin received a call from a nonresident and wanted to confirm we are not selling any graves to non-residents until the new section is opened.

Roads – Dave reported in new business.

Old Business:

- 1. Army Corp of Engineers reminder, meeting September 21st at 1:30 p.m. at the fire station.
- 2. Electronic Sign Beau Miller received another quote from a vendor. However this vendor's price was the highest of the three. We are waiting on the electric contractor quote for the conversion of the 110 to 220 before we make a decision.
- 3. 911 Meeting reminder, meeting August 10th at 6:00 p.m.
- 4. TMACOG Caucus report overview provided by Dave Bench with a lot learned from various government agencies, state representatives and other government leaders.
- 5. Toledo Waterline Dave Bench shared from the recent Toledo Blade article. They found out the old line is steel with 1189 joints, welded and is going to fail in the next five years. Instead of doing the reservoir, they are going to repair the line, a 9-mile section but the EPA wants the City of Toledo to secure property for a future reservoir. Dave Bench is attending this meeting of the regional water group, the group that is using City of Toledo Water. The meeting is on August 18th and is being held at the new fire Station in Perrysburg.
- 6. Radiological Plan Mark Sattler reported he received a revised plan from Hannah Schwartz and it will be placed in the Township office.
- 7. OneOhio Opioid Settlement Mark Sattler has two motions to pass regarding additional agreements to continue our interest in receipt of any funds through the State of Ohio. We have already signed on to the overall memorandum months ago. The two agreements are subdivision settlement participation form for distribution and settlement participation form for janssen settlement.

Mark Sattler made a motion to sign the agreements as a board and have Joel Moszkowicz send onto the three email contacts provided by the Ohio Township Association. Seconded by Dave Bench with roll call as follows:

New Business:

- 1. Mark Stahl Fire Department Dave Bench learned about a program initiative that is on August 17th given by Mark about volunteer fire department support and the State of Ohio. This information was forwarded to Chief Tony Parasiliti.
- 2. Rachel Road Drainage Dave Bench and contractor walking the area to clean the ditch and remove the brush.
- 3. D.I.C. Meeting reminder, meeting August 11th, Dave Bench will be attending on behalf of the Township.
- 4. Board of Elections Setup when voting machines are dropped off for upcoming elections, a special set of keys is available to the Trustees to loan out. These keys limit user access to only the Trustee Chambers and the large hall to ensure the voting machines are secured.
- 5. Recreation Release of Liability Mark Sattler was in communication with Gary Allen and OTARMA, our insurance carrier over a concern over liability coverage for these special program opportunities. The OTARMA guidance suggests we do not employ (W2) the lead instructor for these classes, but engage as a contractor (1099). OTARMA provided us with a generic release customized for Jerusalem Township for future special program use.
- 6. Drone Flyover Mark Sattler was approached by a member of the fire department who is a certified drone operator to volunteer his services. He would like open ended authorization by the board of trustees. Joel will develop a letter of understanding all trustees will sign and share with the individual Josh Swanson.
- 7. Park Fest Mark Sattler shared an update along with Elvis Shepherd. The media has been notified and promotion is ongoing through social media, signs around the Township, and information in the Press Bulletin Board.
- 8. Seaman and Teachout Mark Sattler was contacted by members of the community regarding the road flooding. He indicated we have aggregate staged that local neighbors can use to help with water control. Mark Sattler spoke with our County Engineer contact regarding a more permanent solution because the piles of stone cause a potential (visibility) traffic safety issue at the intersection.

Public Participation

Sue Glass - asked about the gate at Teachout and Seaman. She wanted to know if a pump could be installed to move water? Mark Sattler discussed with her about how wind direction and water level play a factor and how the road grindings are used as a temporary dike to help with water movement on Seaman. She also wanted the Trustees to know that TMACOG is a good resource and they offer a lot to help the Township with operations.

James Boothby asked about the increase in checking account balance from last meeting. The Fiscal Officer explained that the increase was the second of two releases of COVID Relief monies.
