

## Jerusalem Township Board of Trustees Meeting Held on February 14, 2023

The Board of Trustees of Jerusalem Township met in-person in the Township Meeting Room at 9501 Jerusalem Road and by virtual session through Zoom Meeting Online on the above date at 7:00 p.m.

- 2. Salt Shed Cleanup no update.
- 3. Corduory Demolition the contractor reported that the work will start today.
- 4. Rachel Road Well the contractor reported they found the well and working on getting it completed along with the all extra work he has completed through the various County departments.
- 5. Curtis Ditch Survey Dave Bench reported the County Engineers came out and completed the survey as well as along Rachel road.
- 6. District 12 Integrating Committee Dave Bench reported that not too much was done, mostly methodology and some project ranking and rule development. One take away from the meeting was about the sewers in Curtice and it was reported they are waiting on the monies from the State to complete the engineering.
- 7. Corduory Road Bridge Replacement Dave Bench reported the project will start around July and they reported a max of three months for the project to get completed. No firm date has been shared.
- 8. Eastern Maumee Bay Chamber of Commerce Beau Miller reported back to the board about the meeting he attended and he provided the State of Jerusalem Township to everyone in attendance.

#### **Public Participation**

Dennis Rudzinski - He is opposition of property maintenance code the zoning board is working on. He attended the last zoning meeting. He feels it is an exact copy of the Sylvania Township version. He also during the zoning meeting, he learned about the shipping container zoning prohibition and wanted to know how he can get rid of the zoning regulations. He was told by the zoning board he cannot have them. He also reported smoke nuisance from Lake Erie Tree Service wants to know if any complaints were brought to the board of trustees.

Maggie Adeler - she asked the board of trustees if like the City of Toledo declaring crime a safety issue could the RCOG 911 do the same which allows them additional access to sources of grants or other funding. Dave Bench reported that entity is working now to seek funding form the State but will mention next meeting he attends on behalf of the Township.

Dana Bohland - asked about the zoning monthly meetings and why they are not on the Township Calendar. Beau Miller Road on Lakeway road between Rialto down to Cooley is degrading and she has some pictures she wants to share with the road department. She asked about why the website is not

updated on the zoning side and who updates the site. The Fiscal Officer explained that all department heads and individuals such as Gary in zoning, himself or the zoning inspector know how to make changes and works with the Neon Goldfish to update.

Bill Tank - sign out front looks but wants more than two messages. Beau Miller admitted he is going to get more information out on the new sign such as upcoming meetings or other Township messages. Also about the zoning meetings, why did they take a member expiring and roll them over to the board. Other questions were asked about other members terms expiration. He also asked about the recent property acquisitions the Township and if the Township has a real estate license and why are we

Dennis Rudzinski - asked about sensors on the road at the intersection of North Curtice and State Route 2 and how long people wait at the light. Dave Bench reported he has a upcoming meeting with ODOT and will make mention of the lack of sensors in the road.

Sue Glass - complains that the new sign is too busy, hard to read while driving down the road. Beau Miller reported the sign is designed to only allow one message when you pass by the sign, he is working on learning more about what works and what does not.

James Boothby - he asked the CCYC representative Doug Huber if they are going to get the mouth dredged and he reported all paperwork has been completed through the State of Ohio and the Army Corp of Engineers and reports the project will get completed this year.

Lonnie Hart - asked which trustee works with the Landbank, Dave Bench reported the zoning inspector is the primary contact for any communication between the Landbank and Jerusalem Township.

Karen Wilhelm - stated a good way to advertise the zoning meetings is free public notice section in the metro press.
