

# Jerusalem Township Board of Trustees Meeting Held on February 28, 2023

The Board of Trustees of Jerusalem Township met in-person in the Township Meeting Room at 9501 Jerusalem Road and by virtual session through Zoom Meeting Online on the above date at 7:00 p.m.

Mark Sattler opened the meeting at 7:00 p.m. with a moment of silence followed by the pledge of allegiance with the members as listed during roll call:

## Approval of Previous Minutes:

The Fiscal Officer's report indicated a fund status of \$611,104.46 in pooled investments and \$523,224.87 in our checking account. We made payments with warrants 21532 through 21557 and electronic payment 23-2023 totaling \$35,367.96. Deposits made since last meeting are \$23,474.58.

The Fiscal Officer asked for a resolution to approve spending \$38,100.00 for 11741 Corduroy which was originally approved in 2022 during the 11/15/2022 Board of Trustee meeting.

Beau Miller made a motion to approve what was already approved in 2022 \$38,100.00 for the 11741 Corduory Road demolition. Seconded by Dave Bench with roll call as follows:

Fire Department: Tony Parasiliti

Safety Message: No message.

Runs to Date: 63 calls to date

We had six fires in a single week which is highly unusual. Tony has been working with the Conservancy Board regarding water levels and historical level tracking. Tony has also been working with the Road Superintendent to identify future areas for dry hydrant installations. Tony reported several fires at various times over at Lake Erie Tree in the organic mulch piles. He also reported one garage fire and one home fire.

Dive training continues at the YMCA with other agencies. On February 21<sup>st</sup> the department sponsored a community CPR class at Jerusalem School. He is looking at March 23<sup>rd</sup> for a community CPR course held at the Fire Station. Lastly he reported radiological training is taking place as well coming up with the Ottawa and Lucas County EMA.

Food Pantry - Richard Hozak

No report, not in attendance.

Reno Beach / Howard Farms Conservancy - Elvis Shepherd

He explained that there was an assertion by a community member that the pumps were not working. A community member contacted a Trustee who immediately alerted a member of the Conservancy Board. The Conservancy Board responded rapidly and also deployed their pump & electrical contractor to visit the sites. All pumps were working properly and no remediation was necessary. It was reinforced by the board of trustees and through the Conservancy representative that the pumps are managed by the Conservancy, not by the Township. Community members were asked to please contact the Conservancy directly. All Conservancy Directors' names, phone numbers, and e-mail addresses are listed on the Reno Beach/Howard Farms Conservancy District web site.

**Recreation:** Gary Allen

Park Fest 2023 has been scheduled for Saturday August 12th 2023. Gary has the contact list from last year. More information to come in the future.

Community Get-Together - Wednesday May 24th from 5-7pm at Jerusalem Elementary.

Lake High School is donating some rolls of used field turf to use at the rec fields. They are replacing their football field turf. This job should be done around the first of April. Each roll is roughly 15 feet x 65-70 feet. Not sure how they will be used yet but this is too good of an opportunity to pass up.

First 2023 Rec Board meeting is next Tuesday March 7th at 7pm. We will be discussing Park Fest, Community day, Joe Verb Park ideas, and uses for the field turf from Lake High School.

Maintenance: Kevin Chapman

Normal maintenance ongoing at the shop. Beau asked if the stop sign at North and Reubens can be checked, resident reported it was missing.

**Cemetery:** Kevin Chapman

Full burial today at cemetery.

### Old Business:

1. Salt Shed Cleanup - Beau Miller opened three sealed bids to consider tonight. Tearing down the cellar, removing concrete tile, fixing bins, and installing earthen mounds up against the bins.

Bid 1 - Groundworks, \$6825.00

Bid 2 - John Belkofer, \$3000.00

Bid 3 - John Gradel, \$9350.00

The board will review and make a decision in a future meeting after comparing the various bids to ensure the scope of work matches our needs.

- 2. ODOT Report Dave Bench reported that the tile was installed at Elliston and Jerusalem Road and is now waiting for the flapper gate. Regarding Jerusalem Township East and West entrances, they reported there was space on existing sign posts to install signs letting travelers know they are entering Jerusalem Township. A traffic light issue on North Curtice and Jerusalem Road that was brought up at the last meeting is being investigated. Dave reported the State Route 2 and Donovan road guardrail is tied into the bridge, so it belongs to the County and is not ODOT's responsibility.
- 3. Ohio Lake Erie Commission Mark Sattler reported the grant was awarded to Jerusalem Township (in partnership with the Reno Beach/Howard Farms Conservancy District for an engineering study of the entire dike system in the amount of \$83,200.00. The request for qualifications was advertised in the Suburban Press, on the Township Web site and Government Facebook page and was e-mailed to 14 different engineering firms. CEC (Civil and Environmental Consultants) is the highest ranked firm.

Mark Sattler moved for approval of the Civil and Environmental Consultants statement of qualifications and requested authorization to move forward pending negotiation of terms and conditions, scope, and fees. Seconded by Beau Miller with roll call as follows:

- 4. Legal Counsel Bill Beau Miller shared concern over the most recent attorney bill that was presented for approval and asked for additional information about the work relating to a Community Improvement Corporation. Mark Sattler reported he will bring more information at the next meeting but shared with the board members an excerpt from passage from the Fassett book History of Oregon and Jerusalem Township Volume II as well as the ORC Title 5 Chapter 404 "Encouraging Economic Development of Township or Area Through Promotion of Tourism. Mark explained the purpose of a Community Improvement Corporation (CIC) and would include a board with at least 40% representation by Township officials and appointees.
- 5. Video Streaming Solution Mark Sattler shared a quote from Torrence Sound that he would like the board to consider. The fiscal officer made a recommendation to see what the cost would be to install a camera or get a system that is portable so that if meetings are held in the main hall they could be used on the same system. Mark also shared the cost of a projector system for the main hall which would cost over \$10,000.00. Beau Miller is not happy with the cost and is worried the ceilingmounted projector could be damaged during Hall rental events.

## **New Business**

- 1. Sacks Road Drainage Dave Bench reported that some tiles had broken and he and Kevin found the owner and repairs were made to address the water flow.
- 2. 2023 OTARMA Insurance Coverage the fiscal officer provided to each department head and each board of trustee member. All have reviewed. Some questions will be asked by the fiscal officer to our OTARMA contact in regards to the house at 9555 Jerusalem Road that the fire department demolished and is still showing on the schedule along with some clarification of coverage for the new electronic sign.

Dave Bench made a motion to increase our general liability limits from \$7 million to \$8 million with an increase of \$794.00 annually with a not to exceed total cost of \$45,000.00 for our 2023 OTARMA coverages. Seconded by Beau Miller with roll call as follows:

Lonnie Hart - asked about the fees that the Township has paid for the assistance with the Community Improvement Corporation mentioned earlier. Beau Miller reported it was 3 hours of attorney time according to the bill.

Aaron Gray - reported that he found two underground tanks (contents unknown) at 11741 Corduroy road. The fire chief will notify the State Fire Marshall.

Maggie Adeler - asked about the option of leaf pickup. Kevin reported the cost would be extreme. She also suggested Gary provides a list of what can be attached to the walls for the hall rental with the rental agreement.

Sandra Nissen - asked if the Township approaches adjacent property owners after they become an owner of a parcel from the land bank. The board of trustees reported no, their process is to post the information on the Township Website and Government Facebook page for individuals to review and make offers on available properties. She also asked when the motion was made by the board to talk to an attorney about the Community Improvement Corporation. Mark Sattler reported she is welcome to look back at the meeting minutes. That would be related to encouraging tourism.
